### ATF Ruling 2016-1

- There are 14 Conditions to be met...
- The highlights...
  - Required Headings
  - Track and retain corrections & changes
  - Search capabilities by each heading
  - Download or Print Locally (Complete A&D history)
  - Storage, Backups & Accessibility Rules
- One for all and all for one...
  - Once you transition, all A&D Records must be maintained electronically

### ATF Ruling 2016-2

- There are 22 Requirements to be met...
- The highlights...
  - Must follow & display the Notices, Instructions, and Definitions
  - Must use same wording as current 4473
  - New form for each transaction
  - All pages must be retained (Currently 6 pages)
  - No auto-fill, Transferee must provide actual inputs, dates & checkmarks

- Pending transaction rules, download or print locally
- Storage, Backups & Accessibility Rules



### ATF Ruling 2021r-05f

- Consolidation Requirements, Manufacture/Importer A&D
- Requires duplicate recordkeeping entries be referenced
- New Heading Requirements
- All records must be maintained until discontinuance of business and A&D records older than 20 years may be maintained electronically
- ATF F 4473s over 20 years may be maintained electronically
  1972



### ATF Ruling 2022-01

- There are 18 Requirements to be met...
- The highlights...
  - Authorizes electronic retention of ATF F 4473
  - Variance no longer required
  - Provide written notification to local ATF Field Division 60 days prior to implementing an electronic AT F 4473 retention system
  - <u>Paper</u> ATF Form 4473 > 3 years old can be scanned and stored electronically
  - Retention Requirements
  - Allow simultaneous access to A&D Records
  - Storage, Backups & Accessibility Rules
