Interesting highlights include:

- Member recruitment and engagement seemed to be one of the biggest issues our societies are currently facing
 - o Issues with payers and insurance was cited as the biggest issues facing rheumatologists
- All but two societies indicated they would like CSRO to email their members directly
 - o A few societies indicated they would like their members to opt-in to this first
- CSRO's Legislative Map Tool is the most used resource, followed by the Action Center, Education Library, then Correspondence Page
 - o Legislative Map Tool: 20 indicated they had used resource
 - o Action Center: 15 indicated they had used resource
 - o Education Library: 10 indicated they had used resource
 - o Correspondence Page: 7 indicated they had used resource
- Support with policy and payer issues was mostly commonly indicated as the most valuable member benefit
- Support with policy and payer issues was also the most used member benefit
 - o Support with policy and payer issues: 23 indicated they had used benefit
 - o Travel stipend for two representatives to attend the CSRO State Society Advocacy Conference: 17 indicated they had used benefit
 - o Exclusive member update emails: 15 indicated they had used benefit
 - o Invitations to meet with state Representatives and Senators in Congress: 15 indicated they had used benefit

- Speaker to provide CSRO advocacy and legislation updates at state society meeting: 12 indicated they had used benefit
