Gary Feldman, MD, FACR

Fellows Conference Presentation: *The Future Environment of Rheumatology*



Gary R. Feldman, MD, FACR currently serves as the President of the Coalition of State Rheumatology Organizations. He practices rheumatology and is the Medical Director of Pacific Arthritis, an independent practice rheumatology group located in Los Angeles and Santa Monica, California.

In addition to his private practice, Dr. Feldman is an Assistant Clinical Professor of Medicine at the David Geffen School of Medicine at the University of California, Los Angeles. He has been involved in clinical research and lectured extensively throughout his career in multiple areas, including inflammatory arthritis, osteoarthritis, crystalline arthropathies, metabolic bone disease, osteoporosis, and biologic therapies for autoimmune and other diseases.

Dr. Feldman was the founding Chair of the American College of Rheumatology Insurance Subcommittee. He served as the President of the California Rheumatology Alliance and continues as the Chair of Advocacy for the California Rheumatology Alliance. He also currently serves on the Board of Directors of the Alliance for Affordable and Transparent Pharmacy representing the California Rheumatology Alliance.

A native of Los Angeles, he completed his undergraduate degree in nutritional science at the University of California, Berkeley before completing his medical degree at Tufts University in Boston, Massachusetts. His postgraduate residency training in internal medicine and fellowship in rheumatology was completed at Cedars-Sinai Medical Center in Los Angeles, California.

Aaron Broadwell, MD

Dr. Aaron Broadwell is a native of Shreveport, Louisiana, graduating from Caddo Magnet High School in 1999. He attended Rhodes College and obtained a Bachelors of Arts in 2003. He began his medical training at The University of Texas Medical Branch, where he received his M.D. in 2007 and was a member of the Alpha Omega Alpha and the Phi Kappa Phi Honor Societies. Louisiana, as well as on the board of the Coalition of State Rheumatology Associations, a nationwide rheumatology advocacy organization.

Mr. McCoy is a graduate of the University of Virginia and the University of Virginia School of Law. He spent the first 11 years of his practice as a partner in the health law section of Williams Mullen, in Richmond, Virginia, where he represented physicians, hospitals and other health care providers.

He left Williams Mullen in 2008 to serve as general counsel to Patient First Corporation, a provider of primary and urgent care services that has grown from 20 locations in two states in 2008 to 77 locations across the mid-Atlantic at present. Patient First employs almost 700 physicians and extenders, who treat patients during more than 3.2 million visits annually.

Mr. McCoy is the past chair of the Health Law Section of the Virginia State Bar and is currently a member of the Board of Governors of the Virginia Bar Association's Health Law Council.

Michael Saitta, MD, MBA, FACR

Additionally, she is a past Chair of the Alliance for Safe Biologic Medicines, past member of the American College of Rheumatology insurance subcommittee, and Clinical Assistant Professor of Medicine at Tulane University School of Medicine.

Dr. Feldman is a nationally recognized expert on formulary construction, its effect on drug pricing, and patient access to care. Her articles and opinion editorials have been published in major health media outlets. She is a highly sought speaker, lecturing extensively to patients, physicians, regulators, and legislators. She has testified in front of our national Congress, as well as several state legislatures, the Federal Trade Commission, and the World Health Organization.

Dr. Feldman is honored to be the recipient of the American College of Rheumatology's inaugural 2021 Innovation in Clinical Care award. She received the Distinguished Service Award for Tulane Medical School, was named one of the Top Women in New Orleans by City Business in 2017, and is the former radio talk show host of "Driving with Dr. Mattie."

James M. Dahle, MD, FACEP

James M. Dahle, MD, is a practicing emergency physician and Air Force veteran from Salt Lake City, UT. He became interested in personal finance and investing after becoming disillusioned with the way he was treated by several unscrupulous financial professionals.

In an effort to help his fellow physicians and other high-income professionals avoid the same errors, he started The White Coat Investor website in 2011. It rapidly grew into the most widely-read, physician-specific personal finance and investing website in the world. He has written four Amazon best-selling books, publishes two weekly podcasts, developed multiple online courses, and holds an annual conference all aimed at helping his fellow physicians become more financially literate.

He is convinced that increasing the financial security of doctors enables them to be better partners, parents, and doctors along with reducing burnout, decreasing suicide risk, and improving patient care. He has been featured in Forbes and CNN and is a regular columnist for ACEP Now. Dr. Dahle enjoys canyoneering, skiing, biking and spending time with his wife and four kids.
