



2024 IRC Update

Course Outline

Cost: \$77, allowing for 120 days of access.

Course Description: This **5-module** course focuses on the updates to the *2024 International Residential Code (IRC)*. It teaches the practical application of the IRC, focusing on the difference between the 2021 and 2024 versions of the codes. Each module consists of an integrated video presentation, including presentation slides, explanation, examples, and review quizzes. Modules are designed to be approximately 15 to 55 minutes in length.

Course Objectives: This course is designed to make those already familiar with older versions of the IRC aware of the changes that have been made to the 2024 version of the code. You will learn what has been added, what has been removed, and what has been changed.

Texts and Readings: The *2024 International Residential Code (IRC)* is the textbook for this course. It is highly recommended that you purchase a paperback copy of these codes, which are available online at www.iccsafe.org and serve as a valuable reference for in the field inspections.

We have laid out a plan and method to help you learn the material, but it's up to you to put in the work necessary for you to master the material. You can progress through this course at your own pace; however, you only have access for 120 days.
