SUBJECT: <u>Notification of Firearm Safety Certificate (FSC) Materials Update in the Firearm Certification System</u> (FCS)

The California Department of Justice, Bureau of Firearms, is providing this advisory to inform you of important updates to the Firearm Safety Certificate (FSC) materials available within the Firearm Certification System (FCS) and on the Attorney General's Website.

These updates reflect statutory changes enacted by Assembly Bill (AB) 1598 (Stats. 2023, ch. 248). In accordance with this legislation, revisions have been made to ensure FSC training materials align with current California law and best practices.

Updated Content Areas Include:

- Laws regarding the carrying and handling of firearms, particularly handguns.
- Responsibilities of firearm ownership.
- Legal requirements for private firearm sales and transfers.
- Laws concerning the permissible use of lethal force.
- Best practices for safe firearm storage.
- Risks associated with firearm ownership and bringing firearms into the home, including increased risk of suicide, homicide, or unintentional injury.
- Prevention strategies to mitigate those risks.
- Eligibility laws, including those related to gun violence restraining orders, domestic violence restraining orders, and privately manufactured firearms.


