Goals of the Fellowship

Increase evidence-based policymaking on policy issues impacting children and families.

Grow the number of trained researchers with policy skills.

Build a network of experts who can bridge developmental science, state policymaking, and practice.

Why apply?

Three placements:



State agencies

Work in a state capitol on the implementation side of policy, assisting in the design, implementation or analysis for program evaluation that reach young children and families.



Federal agencies

Live in Washington, D.C. while you develop research funding, support regulatory processes, provide technical assistance to childcare programs, and more, depending on the office.



U.S. Congress

Be in the room where it happens. Work in the fast-paced Capitol Hill, on multiple projects. Use your expertise to assess legislation's impact on young children, advise on policy, draft memos, and more.

Generous stipend, along with allowances for moving expenses, health insurance, and professional development

Find a State Placement

State applicants must find an interested state agency <u>before</u> applying (this helps you be a fellow in the state you live, if moving to D.C. is not possible for you).

The Application

CHANGES, TIPS, AND TRICKS

Who should apply?

You will be most successful if you are <u>eager to learn</u>, are <u>committed to diversity, equity, and inclusion</u>, and are <u>passionate about bringing evidence into the policy space</u>.

SRCD is deeply committed to diversity in all its forms.

We highly encourage fellowship applications from scholars of color, scholars from underrepresented cultural and ethnic backgrounds, scholars from low-income backgrounds, firstgeneration college graduates, scholars with disabilities, and scholars from the LGBTQIA+ community.



Who is eligible?

You must be:

- Member of SRCD.
- Doctoral-level degree (e.g., Ph.D., Ed.D., M.D.) relevant to child development by August 2024.
- Citizenship must be a US citizen for federal agency and U.S. Congress placements (due to rules at those institutions). For state agencies, citizenship can vary; applicants <u>must</u> confirm with state agencies before applying.
- Congressional and state placements must be focused on young children ages birth through 8 and their families.

Changes to this year's application

We have made changes to the application this year to ensure the application review process is more equitable:

- Name/institution blind for reviewers
- Clearly defined skills and scoring against those skills
- Increased support to reduce barriers for those interested in applying to the state placement

We have also instituted slight changes to the application process, including

- Moving from narrative recommendation letters to surveys
- Having applicants complete a skills survey
- Including a research task in the interview phase

What are we looking for in candidates?

Evaluated Skills

Technical skills (developmental science, research design and methodology)

Openness to growth and learning

Appreciation for and commitment to diversity, equity, and inclusion

Communication

Critical thinking and creative problem solving

Initiative-taking

Reliability

Application Process and Components

Written Application

- Basic information (e.g., demographics, eligibility criteria,)
- Skills survey
- Publications and experience
- Personal statement
- Reference survey (3 references)
- Transcript
- State placement only: Letter of support from the state agency

Interview Phase for Finalists

- Short presentation on assigned task
- Interviews with SRCD review panel
 - In-person for federal executive branch placements
 - Virtual for Congressional and State
- Interviews with potential agencies (executive branch agencies only)

Timeline

Date	Event
January 7, 2024	Written applications due
February 26 – 30, 2024	Interviews for finalists (in DC for executive branch)
March 2024	Fellowship offers finalized
September 1, 2024	Fellowship begins (Congressional fellowship placements identified)

Tips and Tricks

Do not be afraid to apply if you have no policy experience!

Be open to working on topics and issues with which you may have no prior experience

Be honest in the skills survey – we are not expecting you to have all listed skills or experience

Tell us why you are interested and what you hope to gain from the experience

Reach out for help – especially (but not only) if you are looking for a state agency placement!

Applications are due January 7, 2024
