#### The Challenges of Returning to School During a Pandemic Cheryl Blake, MSN, RN, NCSN

On August 6, the PIPSN Leadership provided a Zoom meeting PowerPoint presentation to address some of the challenges private, independent, and parochial school nurses may well face when returning to in-person learning for the 20-21 academic year. This presentation was made available to PIPSNs regardless of their membership in NASN. Approximately 90 school



nurse participants attended this offering.

The main goals of the presentation included identifying ways to assist faculty and students with the transition back to campus, isolation and health room design considerations, self-care strategies and mental health challenges, and health education needed to reinforce new strategies at school. During the presentation, the participants submitted many questions and comments. The most common questions pertained to classroom and playground modifications, seeking out PPE and sanitizer sources, and how to handle ill students, masking, outside visitors, and formation of class cohorts.

One crucial point made during this presentation was the importance of school nurses being an advocate and active leader on their school reentry team. All participants were encouraged to take care of themselves during this pandemic, realizing there would be new levels of stress and anxiety this fall. The final message shared for the night was the importance for each of us to network with other school nurse peers at the local, regional, state or national level for support and collegial discussions. This in turn will

advance the health and educational success of our students.

#### PIPSN Educational Program 2021 by Jan Brant, RN, NCSN

The Private, Independent, and Parochial School Nurses (PIPSN) special interest group (SIG) was formed in 1994 to promote communication and exchange of ideas among nurses who work in private, independent, and parochial schools. Professional affiliation for PIPSNs is a necessity if we want to be informed about best practices for addressing school health needs. NASN has school nurse leaders in each of our communities, leaders who provide resources to support PIPSN members.

Martha Dewey Bergren, DNS RN NCSN PHNA-BC FNASN FASHA FAAN is an exceptional role model for leadership in school nursing practice. Dr. Bergren has devoted over thirty years to clinical and academic work. Her articles have appeared in over 80 peer-reviewed publications. She has demonstrated that improving healthcare in schools and creating healthy school environments and cultures are the most cost-effective and prudent investments for school-aged children. Besides school nursing, population health, privacy, informatics, journal peer-reviewing and editing, and leadership are all included in her areas of expertise. Last September, Dr. Bergren was named the Executive Editor of the Journal of School Nursing.



On March 2 at 6:30PM EST, Dr. Martha Dewey Bergren, met with over 246 PIPSNs via Zoom to present "If You Know HIPAA, You Don't Know FERPA: Student Health Privacy". Dr. Bergren practiced school nursing at an independent school early in her career. She understands the autonomous nature of being a PIPSN. With the recent COVID-19 pandemic, many of us need guidance about student health privacy and sharing health information about the coronavirus.

I have summarized the following highlights from Dr. Bergren's presentation:

Do you know if your school follows Family Education Rights & Privacy Act (FERPA) or Health Insurance Portability & Accountability Act (HIPAA)? Many of us need to confirm this information with our school administrators. If a private school accepts no federal funds, it is not subject to FERPA. A school that accepts no federal funds would be subject to HIPAA Privacy, Security, and Transaction Rules if it engages in HIPAA transactions, such as electronic billing for any health-related services such as nursing, speech, physical therapy, or psychologist services.

How can you communicate with a healthcare provider about health issues about a student? Be proactive and collect an annual HIPAA compliant authorization for students.

Annual signed, HIPAA compliant authorizations for students are required to communicate with their healthcare providers. If a school requires records or information for assessment and evaluation purposes, healthcare providers are prohibited from releasing information to school nurses unless requested on HIPAA compliant authorization forms. This is required whether a school is covered by FERPA, HIPAA, or neither.

After the presentation, Dr. Bergren answered questions from the PIPSNs. She offered her email address to the audience for additional questions unanswered, and for questions we may encounter in the future. Our PIPSN leadership is setting a date for our next session. We are dedicated to providing all PIPSNs with up-to-date information to be prepared to use best practices for addressing school health needs.

#### PIPSN Monitor Report March 2020 – March 2021 Gail Trano, BSN, RN, CSN

#### PRIVATE, INDEPENDENT AND PAROCHIAL SCHOOL NURSE (PIPSN)



The PIPSN community on <u>SchoolNurseNet (SNN)</u> enables members working in the private, parochial and independent settings networking opportunities with their colleagues in the unique school settings they serve. PIPSNs have special and unique challenges beyond their public-school colleagues reflected by often being the only medical professional in their entire community setting and not having access to broader district support and resources.

School nurses require professional mentoring, supervision, and support. The PIPSN community provides this through participation in discussions on SNN, virtual meetings, presentations and speakers, in our annual business meeting at the NASN conferences, by outreach and networking at the NASN conferences. All the above offers members the support, mentoring, access to experienced colleagues and resources they require as professional nurses working in the PIP school settings. Members get to know each other through participation and create supportive and collegial relationships with fellow members. The pandemic this year made this especially important and necessary. Members looked to the PIPSN community with an increased need for information and support specific to our needs and challenges.

When a member enrolls in PIPSN, a NASN Special Interest Group (SIG), via the membership application or NASN profile, they are automatically given access to the Private, Independent & Parochial School Nurses community on SchoolNurseNet. Participation in the community forum is encouraged as we share support of PIPSNs through our discussions, the PIPSN Library, sharing of resources and personal professional experiences and expertise beneficial to all members.

Across the board, the numbers show a substantial increase over the last reporting period, a further demonstration of the value and need to our community for members. The total membership of PIPSN is 2,421, an addition of 726 members from the last reporting period. The total number of discussion threads for this reporting period was 407, close to double that of the 2020 report. The Community Library added 81 additional resources bringing the total to 292 contributions in the Library.

All member questions posted to the community received at least one response; none went unanswered. Additionally, 265 posts were sent directly to the individuals in a private one-on-one response, an increase from last year. This points to PIPSNs reaching out individually, as well as, directly within posted discussions; demonstrating the excellent networking opportunities SNN offers PIPSNs to develop collegial relationships forged through active membership and participation in PIPSN. The PIPSN Community forum continues to provide ongoing outreach to members, offering resources of interest, PIPSN initiatives and professional resources.

2021 Outstanding PIPSN Award Recipient

Kristin Beers, MSN, RN, SANE The Lexington School

It is my privilege to announce that Kristin Beers from The Lexington School in Lexington Kentucky has been chosen as the 2021 Outstanding Private, Independent, and Parochial School Nurse (PIPSN) Award Recipient.

Kristin has served as school nurse and health educator at The Lexington School since 2000. Nurse Kristin has been described as being inspirational and having a tremendous amount of grace under pressure. She provides community education and develops health units that encompass her schools core curriculum while uniting the various disciplines at school.

When COVID-19 closed her school for the remainder of the 19-20 school year, Kristin found other ways to utilize her time and experience. She joined the Medical Reserves Corp and was trained as a Subject Matter Expert. By working at the DPH nights, holidays, and weekends, she was able to give epidemiologists, nurses and other public health employees a much needed break. Kristin was also approached by an art teacher and two physicians to help design face shields. Kristin jumped at the chance to provide input and deliver supplies to the local law enforcement officers and a rural hospital.

Kristin is an active member of NASN and PIPSN. In 2019, she presented a session at the NASN Annual Conference in Denver. Her presentation, *There's a Health Unit In That Classroom: Creative Collaboration Across Specialties*, focused on ways to partner with faculty and staff to develop curriculum health units. Kristin is currently the PIPSN Co-Chair for Membership, reaching out and inviting private, independent, and parochial school nurses to join NASN and the PIPSN community.

Outside of the school setting, Kristin is certified as a Sexual Assault Nurse Examiner and has worked as a SANE with the Lexington Fayette County Division of Police since 2017. In addition, Kristin recently attended the virtual Legislative Day in Kentucky. During this time, she was able to make a speech about being a PIPSN and the need to support a Kentucky bill aimed at increasing the number of school nurses in her state. Her message to all school nurses is: "Get involved and let your voice be heard".
