






Title V Production




89th Legislative Session





Port Arthur LNG Decision

- November 14, 2023 - The U.S. Court of Appeals for the 5th Circuit remand.
 - Remand was based on BACT analysis identifying that a similar facility had lower NO_x and CO limits.
- February 16, 2024 - The U.S. Court of Appeals for the 5th Circuit action.
- February 14, 2025 – Supreme Court of Texas issued an opinion answering the certified question from the 5th Circuit.

EMEW Version 3.0 Update

- Released TBA; required for use July 1, 2025
- Updated to:
 - Be more **Consistent** with other APD workbooks
 - Be **Fully Accessible**
 - Improve **User Friendliness** for applicant submission and TCEQ review
 - **Streamline** submissions with clear directions
 - Incorporate lessons learned to **Reduce back and forth**
