Presentation Overview

- The United States and Mexico have over 40 years of environmental cooperation
 - August 14, 1983 – La Paz Agreement signed by Presidents Ronald Reagan and Miguel de la Madrid
 - Agreement between the United States of America and the United Mexican States on Cooperation for the Protection and Improvement of the Environment in the Border Area
 - October 27, 1992 – Enterprise for the Americas Initiative Act PL102-532 and EO 12916 establish the Good Neighbor Environmental Board

La Paz Agreement – Article 1

- **“to establish the basis of cooperation between the Parties for the protection, improvement, and conservation of the environment and the problems which affect it, as well as to agree on necessary measures to prevent and control pollution in the border area, and to provide the framework for development of a system of notification for emergency situations.”**

La Paz Agreement – Articles 2-7

- 2: Both parties pledge to “cooperate in the solution of problems of mutual concern in the border area”;
- 3: “Conclude specific arrangements for the solution of common problems in the border area” to be appended to the LPA as annexes;
- 4: Border area is defined as 100 km (62 miles) north and south of the international boundary
- 5: Coordination to address problems of air, land, and water pollution
- 6: Pursue coordinated measures in a practical, legal, institutional, and technical manner
- 7: Assess projects that will have a significant impact on the border environment

Tijuana River and Support for IBWC Minutes

- Facilitated EPA, NADB and other U.S. & Mexican agencies collaboration to find solutions to the Tijuana River and sewage problems
- Helped with Minute 320 which established the binational framework on trash and sedimentation
- Provided the mechanism for the current rehab of the International Sewage Treatment Plant and Tijuana's municipal sanitation system (Minute 328, July 19, 2022).

- True regional collaboration in the management of the tri-state airshed
- Development of the Binational Air Quality Fund (BAQF) held at NADB

Rio Grande River Water Quality
