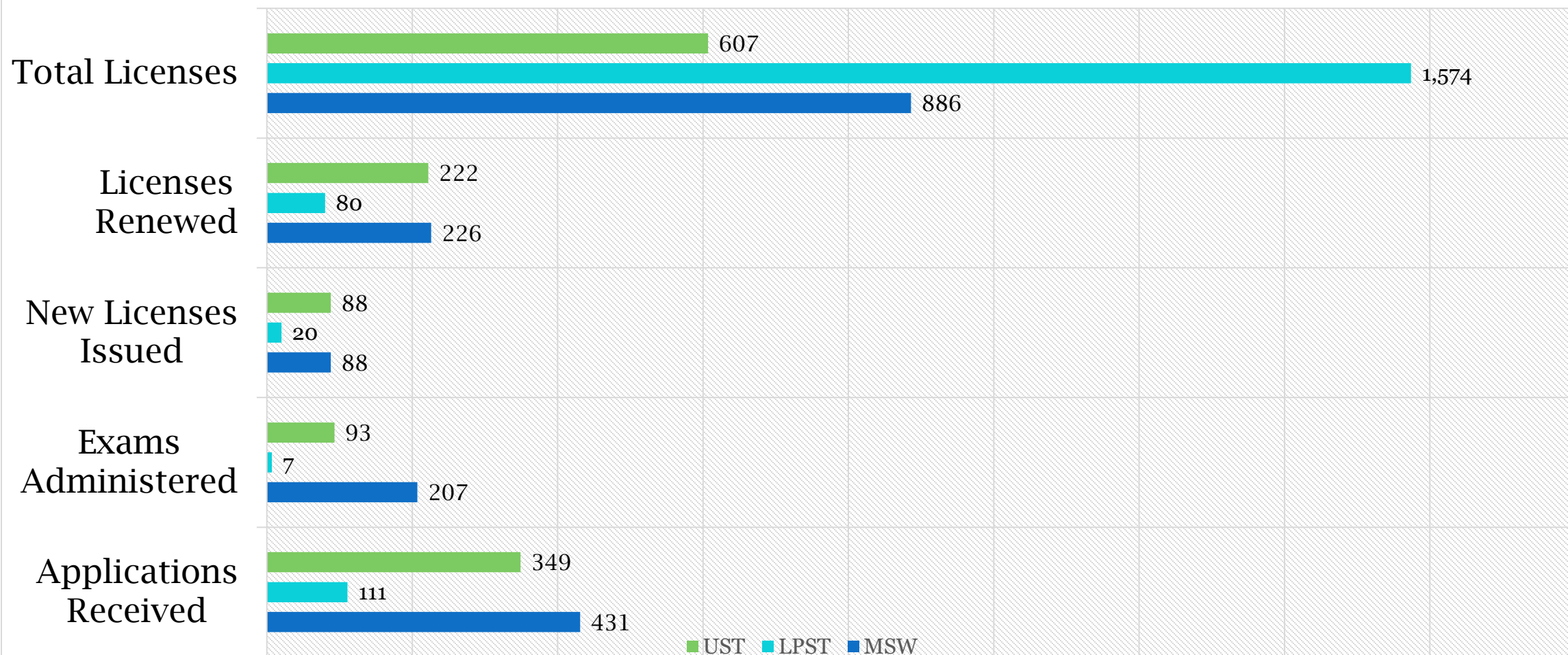

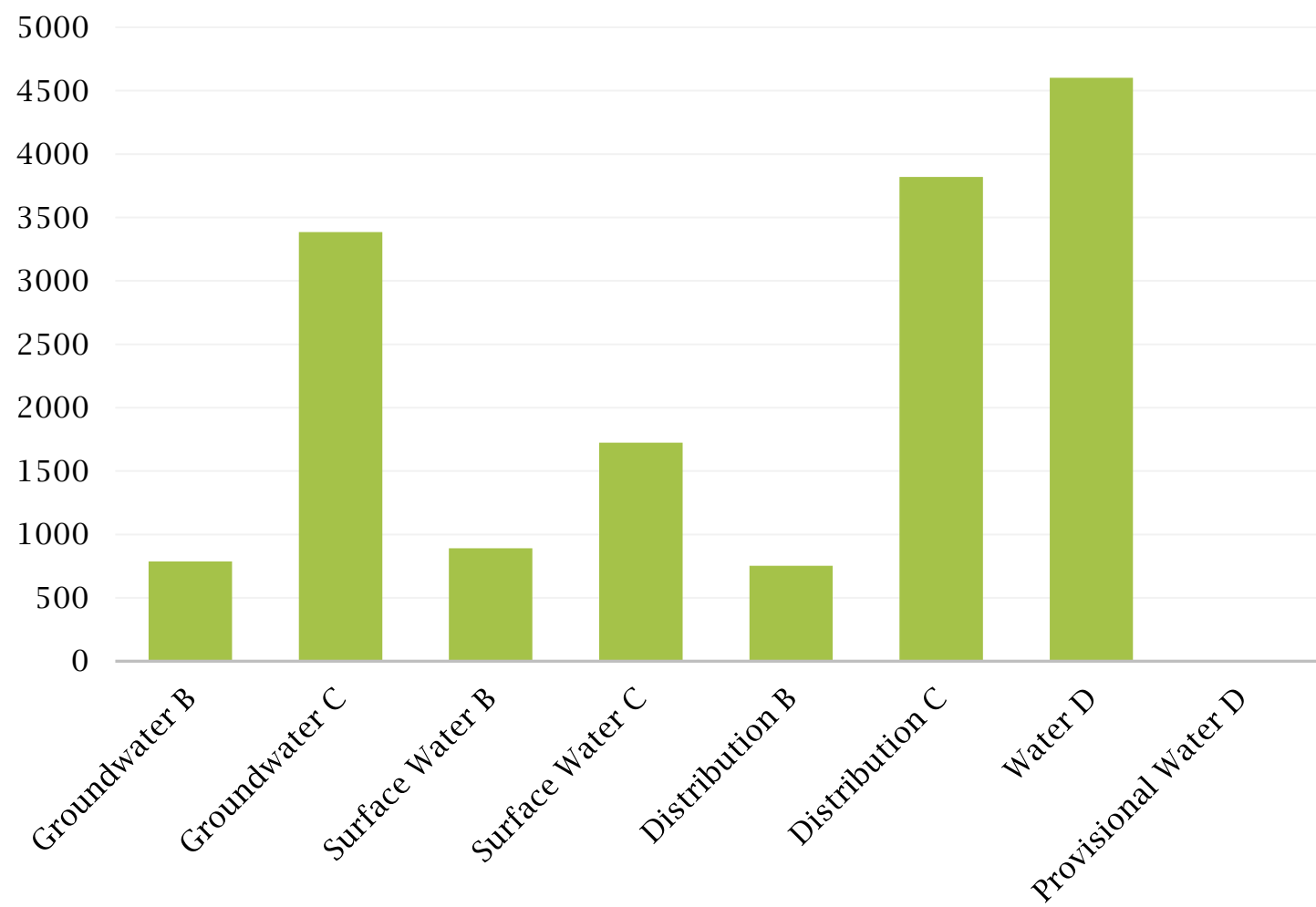

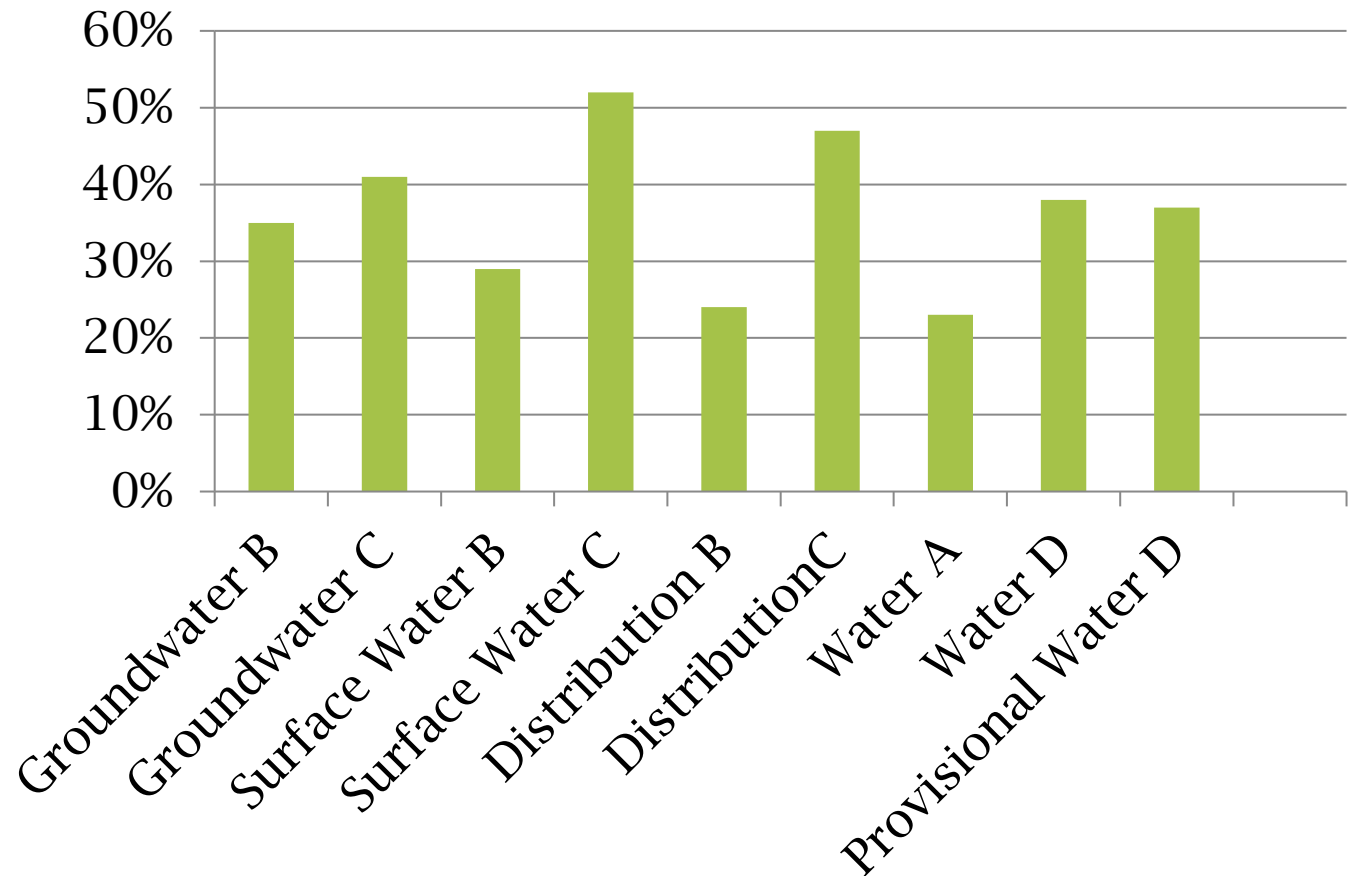

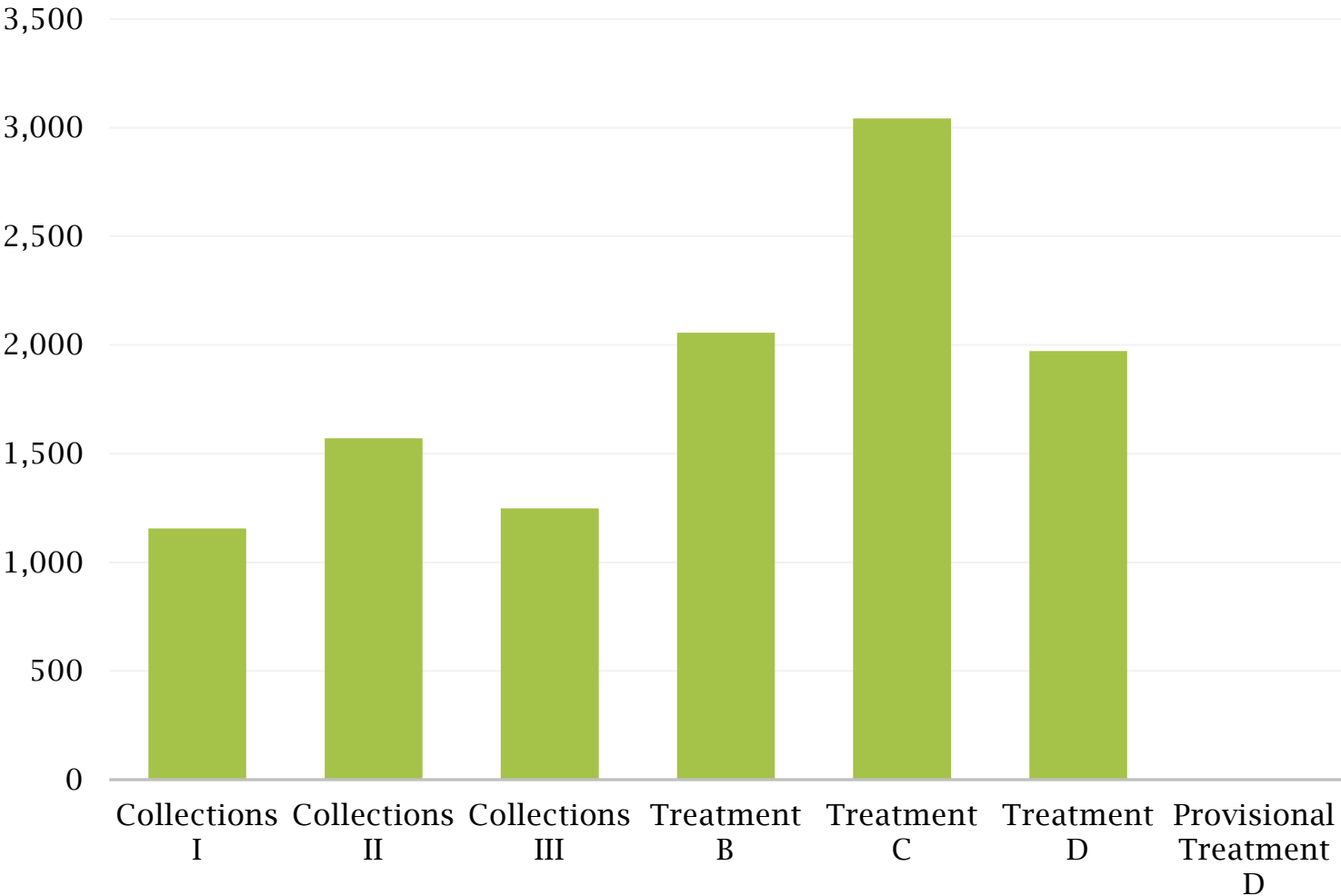

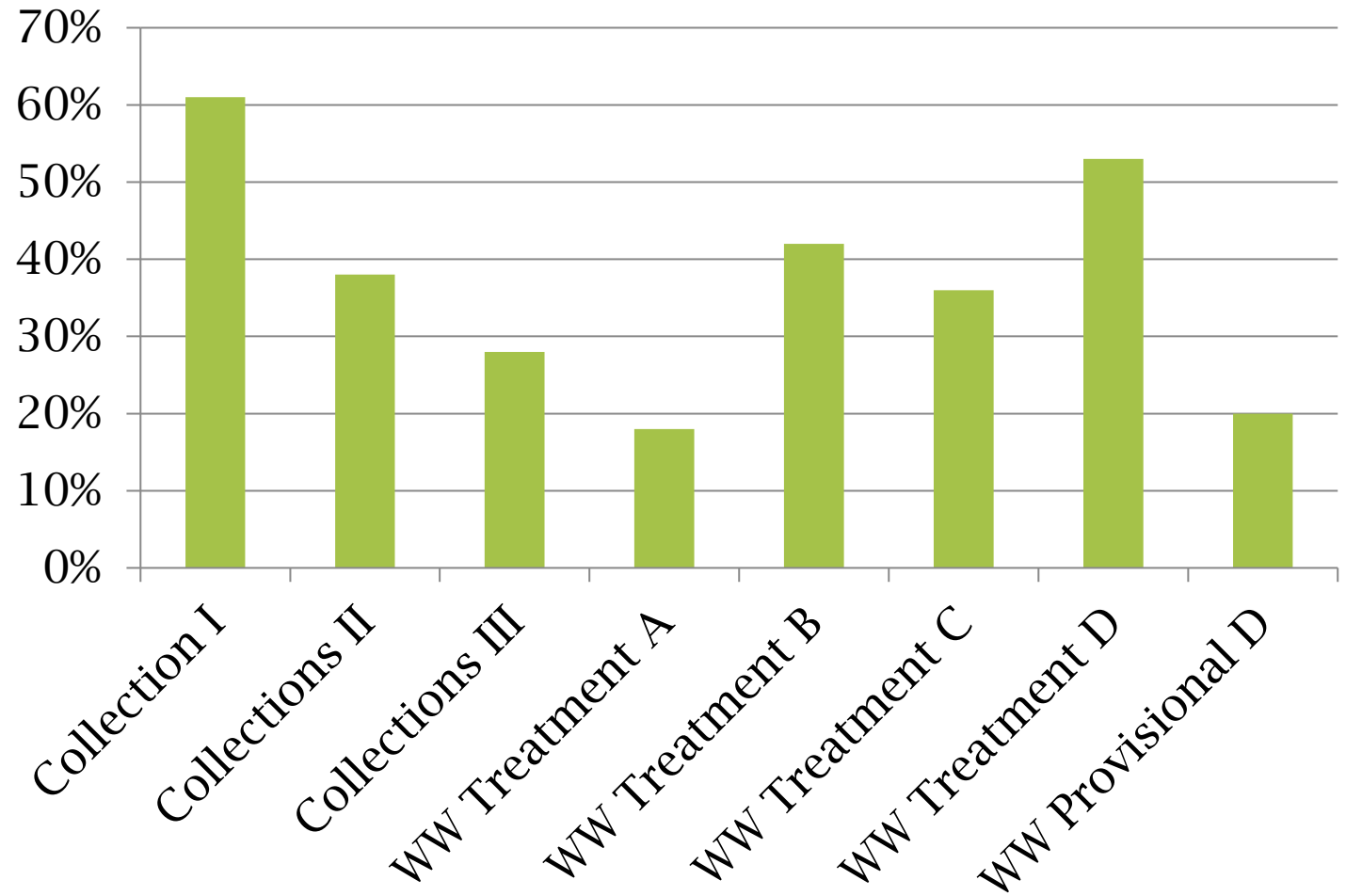

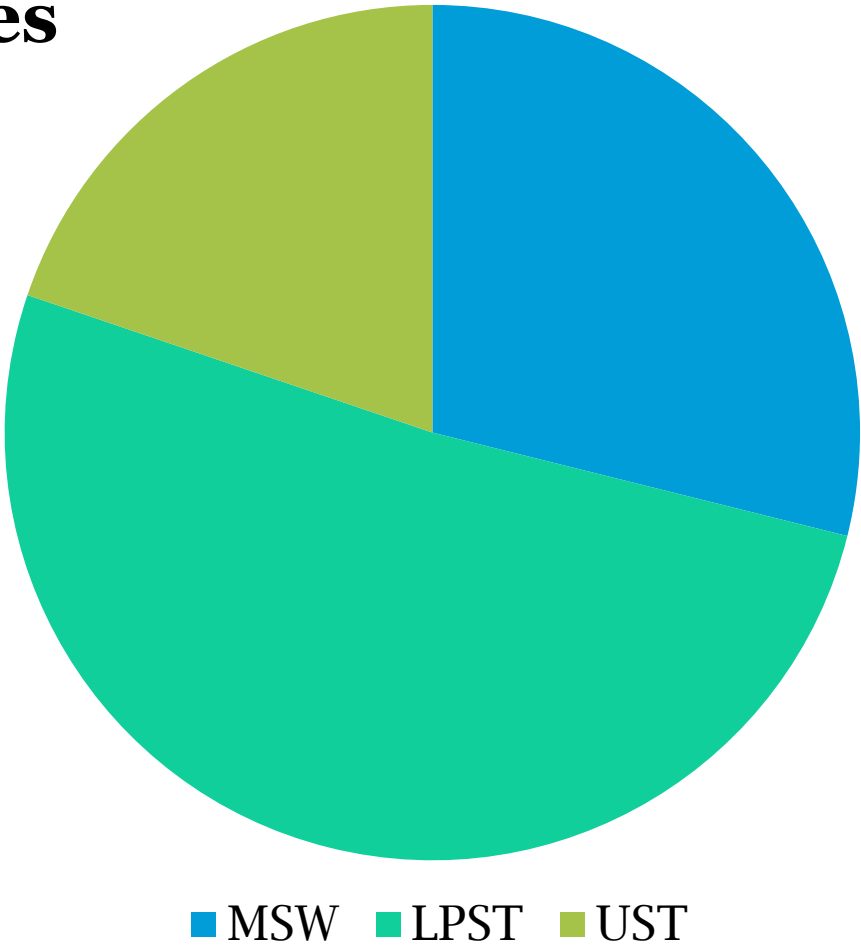

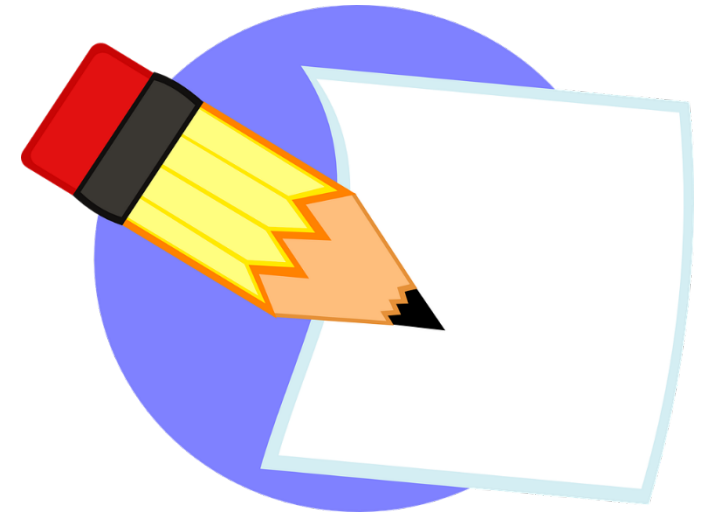
# Paper License Exams

- Paper exams are only available for individuals who meet the criteria in the American Disabilities Act (ADA).
- Be sure to complete ADA form on the website and contact TCEQ.
- Once you have been approved, then a licensing specialist will coordinate a date, time, and place for you to take your exam.



# CBT License Exams

- All TCEQ Occupational Licensing Exams are administered at approved computer-based testing (CBT) centers.
- The testing fees are established by each CBT center and may vary based on the center. Some test centers may offer one immediate retest on the same day.



# Computer-Based Tests (CBT)

CBT exams not only offer immediate exam scores, but also exam analysis feedback and immediate re-testing in some cases.

*There is at least one computer-based testing center in each of the 16 TCEQ Regions. There are a total of 71 locations statewide.*

# Six-Hour Exams

---

The Water Class A, Wastewater Treatment Class A and Landscape Irrigator Exams are now being administered at CBT centers.

- All these exams are 6 hours
- Not all exams are available at all CBT Centers (call first to confirm)

# OSSF Site Evaluator Exam

---

- As of April 1, 2024, the OSSF Site Evaluator exam was split into two exams; Soil Analysis and written portion.
- The Soil Analysis portion of the exam is administered by TEEX at the completion of the course
- The written portion of the OSSF Site Evaluator exam is now being administered via CBT



# Resiliency Training

As of April 1, 2024, resiliency training is required for all water operators to address preparing for, preventing, and responding to weather emergencies and power outages.

- For new licenses:
  - The Resiliency Overview course must be completed before applying for an initial license or upgrading an existing license.
- For renewals:
  - The Resiliency Overview core course must be taken once in the next two renewal cycles.
  - After the Overview course has been taken, at least two of the 30 CE hours must be resiliency continuing education (CE) training.
  - Resiliency CE will show NO on Individual Search page for the Overview course



# Am I Eligible to Renew?

## **Class D Water**

- Not renewable for operators that:
  - operates groundwater treatment systems of 250 connections or more;
  - operates groundwater treatment systems serving a population of 750 or more;
  - operates surface water treatment system;
  - operates groundwater systems under the influence of surface water;
  - is a supervisor, crew chief, or foremen for distribution systems that have over 250 connections; or
  - operates multiple groundwater systems and the cumulative number of connections exceeds 250 or the total population served is 750 or more.

# Am I Eligible to Renew?

## **Class D Wastewater**

- Not renewable for operators at:
  - any activated sludge-type treatment facility of any size;
  - any trickling filter or RBC facility with a permitted average daily flow of 100,000 gallons per day or greater; or
  - any wastewater facility that disposes of treated effluent through a subsurface area drip dispersal system.

# Am I Eligible to Renew?

## **Provisional Water & Wastewater D Licenses**

- Not renewable or re-obtainable
- Valid for 2 years
- Can be upgraded to a D license with proof of high school diploma or equivalent



# When Can I Renew?



You can renew a license up to 90 days prior to the expiration date but no more than 30 days after the expiration date.

Texas Water Code 37.006 prohibits renewals over 30 days past expiration.

*37.006(g), an individual whose license renewal application is not received by the executive director or is not postmarked within 30 days after the license expiration date may not renew the license and must meet the current education, training, and experience requirements, submit a new application with the appropriate fee, and pass the examination.*
