# Important Dates to Remember

- The air fees program operates on the FY instead of the calendar year.
  - The fiscal year runs from September 1st through August 31st each year.
- The air fees program is currently collecting fee information for FY26, corresponding to 9/1/2025 through 8/31/2026.
- The deadline to submit fee data was June 2, 2025.
- FY26 invoices will be sent in October 2025.

# Two Annual Air Fees

30 Texas Administrative  
Code (TAC) Section 101.24

AKA the “air inspection fee”

Collected to recover the  
cost of TCEQ air programs

30 TAC Section 101.27

AKA the “air emissions fee”

Collected to recover the  
direct and indirect costs of  
the Federal Operating Permit  
(Title V) program

# Fee Rates

- Inspection fee rate
  - Fee rate based on the standard industrial classification (SIC) code and description as listed in 30 TAC Section 101.24(f).
- Emissions fee rate
  - The fee is based on the allowable or actual emissions (last full calendar year) of all regulated pollutants at the site.
    - Under no circumstances may the fee basis be less than the actual emissions.
  - Fees are assessed up to 4,000 tons for each regulated pollutant.

# Fee Rates (cont.)

- Fee rates are adjusted annually based on the consumer price index and updated no later than October 1st.

# Reporting Site Status

- Only one status may be reported for a facility.
  - Please review the status definitions below before completing the form.
- Active
  - Account will be active / operational for **any portion** of the fiscal year.
- Idle
  - Account will not operate for **any portion** of the fiscal year. The site still retains the ability to operate in the future.

# Site Status: Shutdown and Sold

- Permanently Shutdown
  - Site will **not operate at any point in the future** and was **not sold**. Any air permits connected to the site must be voided.
  - Information required: date of shut down and air permit voidance information.
- Sold
  - New owner information is required to process the fee basis data. It is the **previous owner's** responsibility to provide new owner information.
  - Even if the Air Permits Division has been notified, please contact the Air Fees Team to process the ownership change.
  - Information required: date of sale and new company information.

# Site Status: Merged and Does Not Qualify

- Merged
  - Cannot be processed until the Air Permits Division has approved the merger.
  - Information required: date of merger and regulated entity reference numbers (RN) affected.
- Does Not Qualify
  - Only use if the site does not have an applicable SIC code listed in 30 TAC Section 101.24 and is not required to obtain a Title V permit.
  - An explanation is required.

# Site Status: Under Construction

- Under Construction
  - Use when the site has:
    - Applied for an air permit or has obtained a permit but is under construction; and
    - Will not operate at any point in the fiscal year.
- Bottom line: the Air Fees Team **must** be notified annually of any changes to the site status, even if the changes have already been processed with the Central Registry or Air Permits Division.

# Air Inspection Fee

- A regulated entity operating under one or more of the applicable SIC codes listed in 30 TAC Section 101.24(f) will be assessed an annual air inspection fee.
- If a site operates under more than one applicable SIC code, the SIC code with the highest base fee rate will be assessed.

# Inspection Fee: Determining SIC Code

- Example: A site operating under both the 2819-B and 2821-C SIC codes should report its SIC code as 2821-C, since it has the higher fee.

INORGANIC CHEMICALS	Capacity of at least 100 million lbs/yr	2819	C	\$33,838.02
PLASTICS, MINERALS AND RESINS	Capacity of at least 1 million lbs/yr, but less than 10 million lbs/yr	2821	A	\$7,898.91
PLASTICS, MINERALS AND RESINS	Capacity of at least 10 million lbs/yr, but less than 100 million lbs/yr	2821	B	\$15,797.82
PLASTICS, MINERALS AND RESINS	Capacity of at least 100 million lbs/yr	2821	C	\$31,587.21

# Primary Versus Secondary SIC Codes

- Consider whether a site's primary and secondary SIC codes are both applicable to the inspection fee.
- A site operating under the primary SIC code of 2899-C and the secondary SIC code of 2895-A would report 2895-A, since it has the higher fee.



CARBON BLACK	Capacity of at least 6 million lbs/yr, but less than 50 million lbs/yr	2895	A	\$17,483.82
CARBON BLACK	Capacity of at least 50 million lbs/yr	2895	B	\$34,967.64
CHEMICAL PREPARATIONS	Capacity of at least 1 million lbs/yr, but less than 10 million lbs/yr	2899	A	\$2,259.24
CHEMICAL PREPARATIONS	Capacity of at least 10 million lbs/yr, but less than 100 million lbs/yr	2899	B	\$4,518.48
CHEMICAL PREPARATIONS	Capacity of at least 100 million lbs/yr	2899	C	\$9,028.53

# Air Emissions Fee

- Per 30 TAC Section 101.27, the owner or operator of a site (account) that is required to obtain a federal operating permit, as described in 30 TAC Chapter 122, will be assessed an annual air emissions fee.
- This is not an emissions inventory (EI) fee. There is no charge associated with the EI.
- If a site is subject to both the inspection fee and emissions fee, only the higher of the two fees shall be assessed.

# Air Emissions Fee (cont.)

- The emissions fee is applicable to a site if it is operating under conditions that would require a Title V permit, regardless of authorization status.
- The emissions fee is applicable if the Title V permit was active or the site was operating under Title V conditions for any portion of the fiscal year.
- If the site's Title V permit will expire or be void for the entire fiscal year, provide supporting documentation along with the fee basis data.

# Reporting Emissions

- A site can report the site-level allowable emissions rates or actual routine emissions of all regulated pollutants from all individual emissions points or process units at the site.
- Regardless of whether the site is reporting allowable or actual routine emissions:
  - Include all regulated pollutants per 30 TAC Section 101.27(f)(3).
  - Include scheduled maintenance, startup, and shutdown (SMSS) emissions, as well as emissions events (EE).

# Reporting Allowable Emissions

- Allowable emissions rates are the site's potential-to-emit (PTE) thresholds.
- Allowable emissions rates include limits specified in:
  - an enforceable document such as a permit;
  - a certified registration of emissions; or
  - a Commission Order.
- These limits must be in effect during the fiscal year that the emissions fee is assessed.

# Reporting Actual Emissions

- Actual emissions are based on the last full calendar-year emissions and are associated with authorized routine activities, SMSS, and EE.
  - A complete and verifiable point source EI can be submitted in lieu of submitting permit allowables.
- All EE emissions should be reported, regardless of whether the EE emissions are classified as “reportable” or “non-reportable,” as defined in 30 TAC Sections 101.1 and 101.201.

# Authorized MSS Versus SMSS Reporting

- Authorized maintenance, start-up, and shutdown **(MSS)** emissions
  - Emissions that are authorized through a permit.
  - These emissions should be reported in the annual routine emissions category.
- **Scheduled** maintenance, start-up, and shutdown **(SMSS)** emissions
  - Emissions as defined in 30 TAC Sections 101.1 and 101.211.
  - These are not permitted emissions.
  - These emissions are reported in the SMSS emissions category.

# Emissions Reporting Summary

## Allowable Emissions:

PTE thresholds during the fiscal year that a fee is due.

+

Emissions from all SMSS that are not authorized by a permit.

+

Emissions from all releases due to EEs.

**OR**

## Routine Emissions:

Last full calendar year of actual emissions of all regulated pollutants from all individual emissions points or process units at the site.

+

Emissions from all SMSS that are not authorized by a permit.

+

Emissions from all releases due to EEs.

# What's New: Online Air Fees Reporting

- A State of Texas Electronic Emissions Reporting System (STEERS)-based reporting system for air emissions and inspection fee program has been developed.
- The new program is called the Air Emissions and Inspection Fee (**AEIF**) reporting program.
  - The STEERS fees AEIF program is separate from the EI program, **AEIR**.
- A few changes to the air fees email notification process have been implemented.

# Updated Fee Notification and Reporting Process

- Notification process functions similar to previous years.
  - The site's billing contact will receive an email but with no attachment.
  - A link is provided to download a pre-filled fee basis form in PDF format.
- For FY26, companies have the option to electronically complete the form or manually print, sign, and scan the document.
  - Email completed form to [airfees@tceq.texas.gov](mailto:airfees@tceq.texas.gov).
  - Reference the site's RN or account number in the subject line.

# Updated Fee Notification and Reporting Process – STEERS-AEIF

- The Air Fees Team tested the STEERS-AIEF system during FY25.
- Open for external users during FY26.
  - Paper, email, or STEERS-AEIF are accepted for FY26.
    - Only one option should be used.
- Anticipate full adoption for FY27.
  - STEERS-AEIF is set up similar to the fee basis form. The program will guide the user through each section of the form.
  - The AEIF program will adhere to STEERS security standards. Users will need STEERS account with appropriate authority, similar to AEIR.
